## Enrollment Process:

Step 1:- User must login in the web portal through <u>https://apcpe.aptonline.in</u> and complete the enrollment and registration process along with the payment of applicable online processing fee, non-refundable application fee to participate in the E-Auction cum Drawl of lots process, as per the schedule notified.

## **ULB Registration:**

**Step 10:** In the ULB registration screen the applicant shall select the District and the ULB for which he intends to bid. The applicable online processing fee will be displayed along with the applicable non-refundable application fee as notified. The applicant may at his option upload the consent letter of the owner of the proposed Bar premises, if it is not owned. He may also, at his option ,upload blue print of the proposed Bar premises and click on 'add' button. Each application filed by the applicant shall be allotted a unique number.( example xxx/xxx/xxx indicating district code, ULB Code, number of the applicant in serial)

Applicant can apply for one or more bars in one or more ULBs. If he/she intends to apply for more than one bar, he/she shall click on the 'Add' tab and enter the details.
